Course 2 content

- This e-learning course covers the practical issues relating to medicines administration support for all social care workers in a client-facing role, upskilling them to administer different types of medicine formulations.
- It has seven modules, three case studies and a final exam with a 70% pass mark.
- Each module is accompanied by a video giving a practical demonstration of the administration process for each type of medicine formulation.
- Once the course is passed a certificate of completion will be issued.
