Placements made outside of Somerset	<p>For 2026/27 Somerset Council will match, <b>but not exceed</b>, the relevant increase offered by the host Local Authority (LA). If the host LA has a standard rate that is applicable to the placement then Somerset Council will match <b>whichever is lower</b> of:</p> <ol style="list-style-type: none"> <li>1. An uplift to the standard rate offered by the host LA, or</li> <li>2. An uplift based on the existing rate paid by Somerset Council, <i>plus</i> the percentage uplift applied by the host LA to reach its new standard rate</li> </ol> <p>Where a host LA does not have an applicable standard rate and instead applies a percentage uplift then Somerset Council will match, but not exceed the applicable percentage uplift.</p> <p>Where none of the above apply and the host LA uses a benchmarking tool in place of offering a standard rate or percentage uplift then Somerset Council will use its chosen benchmarking tool for local services to establish its best and final offer.</p>
